
**ORDER**

WHEREAS, Grace Teacher Training Institute, Kanyakumari, Tamilnadu was granted recognition for offering D.T.Ed course with an intake of 50 students on 18.11.2005 with the condition to shift to own premises within 3 years and D.T.Ed-AI with an intake of 50 students on 11.01.2008 at Grace Nursing Home Complex, PPM Junction, Kaliakkavilai-629153, Kanyakumari District (Total 100 intake).

AND WHEREAS, Grace College of Education, Kanyakumari TamilNadu was granted recognition for offering B.Ed course with an intake of 100 students on 03/03/2008.

AND WHEREAS, SRC in its 181<sup>st</sup> meeting held on 20-21<sup>st</sup> August 2009 where in it was decided that the institution which have not shifted to the permanent premises even after the expiry of three years time limit be issued notice under section 17 of NCTE Act for further action. The institution vide its letter dated has submitted Rs.40000/- on 01.02.2010.

AND WHEREAS, as per the decision of SRC a notice was issued to the institution on 23.07.2010 as per file no. APS03911. The institution has submitted its reply on 06.09.2010 stating that they have shifted to permanent building at Padanthalumoodu, Kanyakumari-629194 from academic year 2007-08 vide letter dated 7.8.2007.

AND WHEREAS, SRC considered the reply in its 196<sup>th</sup> meeting held on 15<sup>th</sup>-19<sup>th</sup> September 2010 and decided to cause inspection for shifting of premises. The inspection of the institution for shifting of premises was carried out on 22.11.2010. The Committee in its 199<sup>th</sup> meeting held on 22<sup>nd</sup>-23<sup>rd</sup> December 2010 considered the VT Report, VCD and all the relevant documentary evidences and it was decided to serve Showcause Notice Under Section 17 of NCTE Act. Accordingly notice was issued to the institution on 04.02.2011 for D.T.Ed, D.T.Ed-AI and B.Ed course. The institution has submitted common written representation to show cause notice for D.T.Ed, D.T.Ed-AI, B.Ed on 07.03.2011. Further, the institution has requested for continuation of B.Ed and shifting of D.T.Ed and D.T.Ed-AI.

AND WHEREAS, the Committee in its 202<sup>nd</sup> meeting held on 14<sup>th</sup>-15<sup>th</sup> March 2011 considered the Section 17 Inspection report of the institution, VT Report and all the relevant documentary evidences and also the reply of the institution dt.07.03.2011 and it was decided to await for the reply from DTERT and T.T. University for final decision.

AND WHEREAS, a letter was issued to the institution on 18.04.2011 to submit a letter stating no other courses except B.Ed & D.T.Ed are conducted in the building from affiliating bodies within 30 days.


AND WHEREAS, the institution vide its letter dated 01.06.2011 submitted certificate dt.24.05.2011 from Tamilnadu Teachers Education University stating no other courses except B.Ed & D.T.Ed are conducted in the building.

AND WHEREAS, the Committee considered the VT report of the institution, reply of the institution to the show cause notice and other related documents along with the original file of the institution, and decided that shifting of D.T.Ed (APS03911, D.T.Ed-AI (APS08509) & B.Ed (APS08887) course to new/permanent premises is permitted

NOW, THEREFORE, the institution is permitted to shift to **new permanent premises at No.25/31A, Padanthalumoodu, Kaliakkavilai Village, Kanyakumari District-629194, Tamilnadu** for conducting D.T.Ed course and D.T.Ed-AI with an annual intake of 100 students.

Also order that a copy of this order be published in the Official Gazette.
